REQUIREMENTS:



1. .22 long or .22 Mag Rifle only.
2. Match will consist of 10 minutes sight-in period. 20 minutes for 25 rounds on targets at 50-yard, 2nd round per match, totaling 50 rounds. There are 5 rounds on each target with 5 targets which will add up to 25 rounds. Then change target and 20 minutes for the next 25 rounds on targets.
3. 50 rounds needed for the match and some sight-in rounds.
4. Safety chamber flag for rifle required (available, if needed).
5. Eye and Ear Protection required (available, if needed).
6. There are 4 different shooting groups.

Class A1	Rifle with scope \$450 and above
Class A2	Rifle without scope \$450 and above
Class B1	Rifle with scope \$450 and under
Class B2	Rifle without scope \$450 and under



7. Event is open to the public. Kids welcome with adult supervision.
8. Must sign Release Waiver before shooting.
9. Limited water and pop will be available for purchase.
